### **WELCA Minutes**

February 11, 2025

The St. Pauli Women of the ELCA met on February 11, 2025 at 3:00 pm at the church with 7 members present following a full day of quilting.

President Jan opened with devotions "Confidence and Calm" based on John 16:33.

<u>Secretary's Report</u>: Minutes of the January meeting were read.

Treasurer's Report: January 16, 2025 to February 11, 2025: Income: \$329.00; Expenses \$365.30. Checking account balance: \$1,112.64. Savings balance as of January 31, 2025 \$601.06. CD balance as of 12-31-2024: \$6,542.94.

Kathy moved to approve both secretary and treasurer reports, Sue seconded. Carried.

Stewardship: Eight quilts were made today, and Faye is taking home two baby quilts that we will donate to VIP. Kathy spent the \$21 remaining on the Thrivent card at the consignment store on infant clothing. Lutheran World Relief (LWR) wants quilts 60 x 80" size with no use of microfiber or polar fleece (which we do not). Per the latest instructions from LWR, each fabric kit should include the following: 2 spools of neutral-colored, general-purpose thread, 250-300 yards each; 2 pieces of cotton or cotton-blend fabric (no knits of 100% polyester). Each piece should match one of the following sizes:

- 2 1/4 yards of 60" wide fabric
- 3 yards of 44" wide fabric
- 4 yards of 36" wide fabric

LWR is sending a lot of quilts and health kits to U.S. disaster locations, e.g. hurricane in the southeast and California fire zones.

Kathy got a Thrivent card to defray the costs of our Valentine's Day meals, which we will make and distribute tomorrow.

Council report: No meeting in January, so no report.

Communications: Thank you letters and cards were received from the NW MN Snow (\$60 for gathering and unit offerings), family of Marvin Torkelson, Heritage Center, Prowler Pantry, ELCA for our Thankoffering, scholarship fund and ELCA Good Gifts donations, Northland Rescue, and family of Skip Swanson.

#### Old Business:

Wall hanging: The Heritage Center dinner has been changed to March 3<sup>rd</sup>, but Jan has not received any invitations yet. We will invite the two ladies from the frame shop. Faye read the letter from Karmon Trontvet, executive director of the Hartz Foundation, in which she attached the formal application. Foundation boards don't meet until May or after.

#### **New Business:**


Vacuum: Virginia will check with Don's Repair to see if the worn brushes can be replaced.

#### **Norman Brenna**

November 13, 1951 - April 17, 2025

Norman and Kathy are our St. Pauli Church neighbors.

Norman Otto Brenna, 73, of Thief River Falls, Minnesota, passed away peacefully at his home on April 17, 2025. A beloved husband, father, grandfather, and friend, Norman lived a life of quiet strength, generosity, and devotion to those he loved.

Norman was raised in Ulen, Minnesota, and graduated from Ulen High School in 1969. Following graduation, he proudly served in the United States Marine Corps until 1973, with time stationed in Japan. After his military service, he attained his Associate of Arts degree from Willmar Community College and his Bachelor of Arts degree from the University of Minnesota-Twin Cities.

He spent 30 years working for the Internal Revenue Service as an Agent, serving with integrity and professionalism until his retirement in 2007.

On June 3, 1983, Norman married Kathleen Martell. Together, they shared 41 years of love, laughter, and adventure. He was a longtime member of Immanuel Lutheran Church in Plummer, where he served faithfully as treasurer for many years.

Norman loved to read and was rarely without a book in hand. He found joy in the simple pleasures—spending summer days outdoors watching birds, heading to the casino when he felt lucky (and returning when his luck ran out), and enjoying winters in Texas with Kathy. For the past 15 years, they spent those winters taking long walks, playing Mexican Train dominoes, and enjoying time with their close-knit group of Texan friends.

He treasured hunting trips with his son Erik. In earlier years, they were serious outings, but as time passed, Norman often left the gun behind, and the trips became more about enjoying the moment—and taking a nap—while Erik waited for the big buck to come their way.

He is survived by his loving wife of 41 years, Kathy; his children: Krista Brenna (Corey), Erik (Amy) Brenna, Jason Fimrite (Lorrie), and JaCinda (Scott) Degelder; grandchildren: Jordan, MacKenzie, Spencer, Jayde, Mya, Dawson, Abigail, Henry, and Daisy; and great-grandchild Steele. He is also survived by his sisters: Jean Hanson, Barb Schenck, and Randi Lloyd.

Norman was preceded in death by his parents, Norman and Delores Brenna.

Norman's legacy lives on in the memories held close and the quiet strength and humor he passed on to all who knew and loved him

Funeral services for Norman were held 1:00 pm on Friday, April 25, 2025 at Immanuel Lutheran Church in Plummer, MN with Reverend Jonathan Dodson officiating. Visitation will be held one hour prior to the service at the church on Friday.

## **In Memorium**

Theresa L. (Terri) Torkelson

February 5, 1930 - March 25, 2025

Terri was married to Marion Torkelson and was a sister-in-law to current St. Pauli members Wally Torkelson and Faye Auchenpaugh.

Theresa (Terri) Torkelson was born February 5, 1930, in Carrollville, Wisconsin, to Elpidio and Enidine (Lopez) Lara. Her parents, along with her two eldest siblings, Salvadore and Carmen, had emigrated from Mexico in 1927 in search of better opportunities. Elpidio immediately found work at the Peter Cooper Glue Company, a major employer in Carrollville, where various industries had established operations considered too noxious for



more populated areas. The company made glue and gelatin from animal remnants and provided modest frame homes for its employees for a small fee. The Lara family made their home on High Street.

Carrollville was a vibrant community of immigrants—Armenians, Slavs, Czechs, Hungarians, Hispanics, a single Chinese family, and one Black family—each bringing their own language and culture. Terri recalled that her older siblings initially struggled with English, but thanks to a resourceful teacher who incorporated bits of Russian, Polish, and Spanish into her lessons, they quickly adapted. Soon, English became the common language of playgrounds and friendships.

Terri attended the Carrollville elementary school, where teachers commuted daily from Milwaukee, braving the cold in high heels and fur-trimmed coats. Among her classmates was a person who sat right next to her: Ted Guerard, a French speaker whose family had moved there from Brooks, Minnesota and who would later become her brother-in-law. Terri graduated from South Milwaukee High School in 1948 and immediately took a job in the office at Peter Cooper in Carrollville. (In 1955, the Carrollville area was incorporated into the City of Oak Creek.)

It was through a coworker that Terri first saw a photo of Marion Torkelson, a friend of her coworker's boyfriend. Terri remarked that she "wouldn't mind going out with him," and soon after, the two met at a Bucyrus Erie company picnic, where Marion was employed. Their courtship led to plans for a fall wedding, but when a labor strike at Bucyrus Erie began, Marion and friends decided to seek work in the Alaska Territory (it wouldn't become a state until 1959) where Marion's Aunt Pauline had written there were jobs to be had in the construction business. Terri's father insisted they marry before she joined Marion in this venture, and so they wed on April 1, 1950.

The newlyweds, along with friends Ferdie Finstad and two Oklee natives, embarked on a memorable eight-day journey to Alaska via the snowy, rugged Alcan Highway. Terri would say, "I went on my honeymoon with four guys!" Facing frozen vehicles and frigid temperatures as low as -60°F, they eventually reached Fairbanks—only to find another strike had halted construction work. Moving on to Anchorage, they both found employment at Elmendorf Air Force Base and spent a year in Alaska before returning to Milwaukee.

Their daughter, Brenda Kay, was born on December 26, 1952. In August 1953, a tragic car accident left Terri seriously injured, with paralyzed vocal cords. After extensive therapy, she regained the ability to speak, starting with a whisper that gradually strengthened but she never did regain her full voice.

Terri enjoyed a long career, first with Peter Cooper Company in Carrollville, WI, Elemendorf AFB in Anchorage, AL, Line Material in Cudahy, WI, and later with the South Milwaukee school district, working for the parks department and school operations until her retirement in 1993. In 1967, Terri and Marion welcomed their second child, Steven Lara.

Marion passed away on September 28, 1998. Terri passed away on March 25, 2025, leaving behind a legacy of resilience, kindness, and devotion.

Terri is survived by her children, Brenda and Steven (Georolyn); her grandson, Geoffrey; her brother, Maurice; and her in-laws: Wallace Torkelson, Faye Auchenpaugh, and Pamela Kittridge. She was preceded in death by her beloved husband, Frances Marion; her parents, Elpidio and Enidine Lara; siblings Salvadore, Carmen, Gayle, and Walter; her parents-in-law, Melvin and Helen Torkelson, and in-laws Geraldine Guerard, Willis Torkelson, Marvin Torkelson, Wahna Smith, and Ivette Garrett.

Funeral services were held on March 31, 2025, at Trinity Lutheran Church, South Milwaukee, Wisconsin.



## **Field Trip to Waukon Dairy**

On April 7<sup>th</sup>, 24 church members and friends chartered a bus and toured the Waukon Dairy near Gary, MN. The dairy milks almost 10,000 cows daily and has 45 full-time employees. They buy feed, including corn, corn silage, straw and alfalfa from farmers within five miles of the dairy and by-products such as distillers' grain and soybean meal from area processors.

The cows are not stanchioned when not being milked and have free access to feed. The bedding is all recycled in a fascinating process that extracts all of the liquid.

The cows produce 7,000 gallons of milk daily, which is hauled in nine semi-tractor trailers to Bongards Creamery in Perham, MN, where it is primarily turned into cheese. (Next field trip?)

On the way home, we stopped for lunch at Erickson's Smokehouse Restaurant in Fertile and made a quick stop at Opdahl's to buy homemade donuts and cookies.

## Beautifying the St. Pauli Cemetery

Wahna Smith's children donated all of her memorial funds to the St. Pauli Cemetery to be used for a 14' x 22' gazebo (see illustration below). The gazebo will be situated at the center of far north side directly facing the driveway. The cost of the concrete pad will be paid for with cemetery funds and memorial funds for Ivette Garrett and Marv Torkelson, but there are many additional opportunities to donate toward or give in memory of a loved one. (Order form on the next page.)

St. Pauli Cemetery Association (SPCA) will attach and pay for all memorial markers to ensure they are all similar. Donors have the choice of what is said on the markers, within character limitations.

BENCHES: Four benches total: two 4' for the east and west (shorter) sides and two 6' for the two openings on the north side. These are commercial-grade, powder-coated, steel park benches, bolted to the concrete. Prices include shipping and installation. Two benches have already been spoken for.

CROSS: A solid brass cross for mounting on the inside of the north center post. We

**ORNAMENTAL TREES:** Examples: Tatarian maple, flowering crab, serviceberry, Mountain Frost pear, Japanese tree lilac. Three for the west side and three for the east. Each will have an ID marker for donors. Prices for 8-12' bare root trees: \$150 including pick-up and planting. If any trees should die, SPCA will pay for their replacement.


**PEONIES:** Fern leaf peonies (often called Memorial peonies because they bloom around Memorial Day) for the front of the gazebo. Three to five needed at \$75 each. Wagner Nursery between Fisher and East Grand Forks specializes in these. Familiar old-fashioned peonies (color choice up to donor) \$30-\$50. Wire cages are needed to hold them up during flowering. Deer don't eat peonies, they look good all summer, and they never need transplanting.

ROLLS OF SHEEP FENCING: Needed for cages to put around the trees for deer protection until they reach maturity.

**BOULDERS:** Must be delivered to their spot. Advance notification is required.

GENERAL DONATIONS: Money for good soil fill for the landscaping, edging and mulch.

**VOLUNTEER LABOR:** Four persons capable of being on their knees or going up a 6' ladder to assemble the gazebo. May take 6 hours, so can do it on one day or two.
